

Our office has made an amazing start in securing benefits for our local veterans. This is the highest we have ever been at securing benefits for our local veterans at this point in the year.



There are many active bills in the Illinois General Assembly that are cause for concern for many Veterans Assistance Commissions across the state.

HB 2378 Prop TX-Surviving Spouse - This bill aims to right a wrong where widows of veterans that never applied for the property tax exemption or reduction before they passed are currently barred from receiving any benefits. This bill is working to allow widows of veterans to apply for the property tax relief even if the veteran hasn't before their passing.

It is estimated that this will affect about 700-1000 surviving spouses that live in Illinois.

HB5184 - Veterans Assistance Commission - This bill aims to put into law what has been litigated in court. Some of the more contentious parts of the bill are as follows:

- 1) The Current bill as presented mandates a minimum funding of .02% levy for a Veterans Assistance Commission. There is a house amendment getting drafted for this so that the VAC Board would set the levy up to .02% and the county could only weigh in if between .02% and .03%. For our office budget to be able to get up to .02% levy would mean our office would get an additional sum of about \$138,000 to put this into perspective.
- 2) The second contention many are having is that only Federally Chartered Veterans Service Organizations (VSO) can be members of the board and removes State Chartered VSO from the law. Contentions have been brought up by numerous VSO that do amazing things in the community that want to have a say. The state has not chartered a VSO in years and has no criteria to do so. In relation to this the house amendment is going to still contain State Chartered VSO and another bill is going to be introduced that would create the criteria for Chartering them.
- 3) The over 3,000,000 population doesn't have to have a Veterans Assistance Commission. This part is contentious because the 147 American legions not counting VFW's and other organizations have proved to be troublesome. They all cant agree on anything and as such the Cook County VAC has struggled to leadership turnover and success over the years. Currently, Cook County has 2 VAC's with one run by the veterans service organizations and one by the county. This is much like what happened in Grundy County that there is now case law on stating that a majority of the organizations have the legit VAC but event this has been troublesome.

It is estimated that this will affect about 700-1000 surviving spouses that live in Illinois.

This bill is currently back in Rules Committee so it will take a lot of work to get it out again. Our State Association had compiled some statements from widows in which this bill would affect and preparing a Resolution. They will be trying to use this to help many legislators understand the profound impact this will make on a few widows whose spouses were taken to early.

HB5184 - Veterans Assistance Commission - This bill aims to put into law what has been litigated in court. 3/4/2022 This bill passed the Illinois House of Representatives unanimously and moved on to the Senate.

In the Senate Senator Craig Wilcox (R), Senator Antonio Munoz (D), Senator Jason Plummer (D), all are chief sponsors of the bill as it works its way through. There is supposed to be some technical changes made by the Senate on this bill but still waiting to find out what those are.

Lastly, it affords those that are 100% permanent and total not to have to re-file every year for the exemption. This bill has passed both houses and on the the Governor for signing.

HB5184 - Veterans Assistance Commission - This bill aims to put into law what has been litigated in court. This bill passed both houses and on to the Governor's office for signing.

The two active bills in the Illinois General Assembly that effect our office as well as our Veterans and Families have been passed/signed:

SB 1975 - <u>Property Tax Exemptions</u>: Exemptions for those receiving the Veterans with Disabilities Exemption will auto-renew if the qualifying veteran is deemed permanently and totally disabled by the U.S. Department of Veterans Affairs. For taxable year 2023 and thereafter, if the taxpayer is the surviving spouse of a veteran whose death was determined to be service-connected and who is certified by the United States Department of Veterans Affairs as a recipient of dependency and indemnity compensation under federal law, then the property is also exempt from taxation under this Code.

HB5184 - <u>Amends the Military Veterans Assistance Act</u>. Provides that the previous endorsed changes are now written into law. Changing and amending topics that now make things more understandable and less to misconstrue. Effective: Jan 1, 2023







The office has seen a lot of new clients, phone calls regarding PACT ACT and Camp Lejeune are in abundance. We are booking into November right now and there's no end in sight- which we welcome. We are very proud of what we have done and continue to do for our Veterans & Families.

Christa discussed the Events coming up- Flu Clinics (we have 3 dates available)- more dates possible if need arises. Also that the signage for the building has arrived and we are very happy with it.

Christa then discussed that we were going to Cedar Creek Ranch on October 7th along with Hines Suicide Prevention Team and AllenForce to come up with a program for our Veterans.

Christa talked about training in East Peoria that her and Lissa attended. There were BVA mock hearings, law judges, C&P exam Q&A session, info on the PACT ACT, Secondary Condition submission information, Caregiver Support guidance and more.

Christa informed the Board about the Accreditation for the Office that the State Association is putting together. OFFICE SUMMARY

OVERVIEW

The LaSalle County Veterans Assistance Commission (VAC) assists Veterans and their Families find and apply for any benefits they may be eligible for.

IMPACT STATEMENT

By assisting the Veterans and Families with benefits, the LaSalle County VAC brings in compensation payments to those who are eligible. This in turn allows for the Veterans and Families to stay in their communities and helps the area in which they reside thrive.

FISCAL YEAR 2022 RESULTS

In fiscal year 2022, the LaSalle County VAC netted over \$5.8 million dollars in benefits paid directly to our Veterans and Families. The office also assisted in paying over \$13,000 in rent/utility payments for Veterans in need. Overall, the office has increased payouts to Veterans by over double of what was produced in FY2021.

PARTNERSHIPS

The LaSalle County VAC not only assisted Veterans and Families financially, we also hosted, created and held events/programs that benefited our Veterans as well. This year we partnered with AllenForce, Hines VA Medical Center, Leashes for Living Assistance, local gyms, Veteran Readiness & Employment (VR&E), BEST,inc, VA Home Loans, National Louis University, Hines Caregiver Team, Hines Mental Health Team and more.

FUTURE GOALS

The goal of the LaSalle County VAC has always been, and will continue to be, that of assisting our Veterans and their Families in every way possible. Our office has provided great benefits for the county and our Veterans this past year and we will continue to do so for years to come.

Measuring Progress


Claims processing has now reached a 8-12 month wait time from start of the claims process until decision is made with Veterans Affairs. With that, our office was still able to secure over \$5.8 million dollars in benefit payouts for our Veterans and Families. 
Office Visits per Fiscal Year

99% Overall Since moving locations from 119 W Madison St, Ottawa to 4231 Progress Blvd, Peru - our office has seen an increase of inoffice visits of 41% overall. Our outreach locations have seen an increase of 58% as well. We contribute this to being better situated for our Veterans, ease of parking and a quieter space for our Veterans and Families to feel comfortable coming into. The outreach location increase, we feel, is due to more knowledge of where we are located and better marketing for these locations.

Education

We continue to push further education with our staff so we can stay up to date with the new legislature and best practices for our clients. Our office has had one new Veterans Service Officer (VSO) complete the Basic course and get accredited through NACVSO, one VSO take a course on Advanced Appeals and one VSO complete and pass the Certified Veterans Advocate (CVA) course taught by a Veterans Law Attorney. We also continue to attend annual training courses and meetings both state and nation-wide. Our office has attended the Illinois Association of County Officials (IACO) Conference, Illinois Department of Veterans Affairs (IDVA) Conference, Illinois Association of County Veterans Assistance Commissions (IACVAC) Trainings, and the National Association of County Veterans Service Officers (NACVSO) Trainings this past year and will continue to do so in the future.

Financial Aid

The LaSalle County Veterans Assistance Commission not only offers claims assistance, programs and events- we also assist Veterans in their time of need. Whether it is a one-time event or monthly occurrence. In FY 2022, our office has paid claims for direct financial aid totaling \$13,608.85 via vouchers to vendors. These payments are to assist Veterans with either rent/mortgage or utilities payments. It is this office's aim to not only see these Veterans and make sure they are receiving every benefit they are eligible for, but also connect them with other community resources that may be able to further assist them.
